TERMS AND CONDITIONS

Admission into membership:

A new member shall be introduced by an existing Safaricom Staff who Must be a SIC member before admission.

All application of membership must meet the approval of the General Manager or Chief Executive Officer.

Before membership rights may be exercised, a member must:

- Pay a Membership fee of (non-refundable) Kshs. 15,000
- Minimum shares to be purchased in terms of value:
 - (1000 Shares * Kshs.52.5/=)Total amount to pay before registration is Kshs. 67,500/= One off.
- Minimum Monthly contribution
Kshs.15,000 as a group

Representation to investment meetings (special general meetings and annual general meetings) will be by *one* official of the investment group and *one vote per* group irrespective of the number of members.

All individuals are eligible to become members of the society as individuals
